### EVENT RULES:

- All booths should be manned for all the hours they are booked, up to and including 4:00 pm Sunday, June 8, 2025 (***other arrangements may be agreed to before event dates***).
- Booth Space – 10 x 10 space with table and 2 chairs. **Electricity** or extra tables & chairs **must be requested in advance**. Vendors are to supply own shade tents and outdoor-rated electrical extension cords if electricity is pre-booked. Water jugs or weights will be required to stabilize the tents – no staking available on pavement.
- Retail Booth Space \$150 payable to the **BC and Yukon Regional Committee** upon signing of this agreement. Double booth space \$250
